### **Summary**

This report seeks Council's endorsement to prepare a Planning Proposal to amend the *Burwood Local Environmental Plan 2012* by updating the Design Excellence clause. The amendment would require significant developments such as mixed-use and apartment buildings over 28 metres (or 8 storeys) to undergo a competitive design process in line with the *Design Competition Guidelines* (September 2023) prepared by the NSW Government Architect. This process would aim to improve design outcomes across Burwood's higher-density areas and would be required to occur prior to any approval being issued.

The proposal complements the existing Design Review Panel process and supports Council's broader goal of ensuring high-quality architecture and public spaces, particularly in areas like the Town Centre and Burwood North, where growth will involve complex residential developments. Design competitions are a proven method for achieving excellence and innovation in built form, while also delivering wider benefits to community identity, liveability, and the public domain.

# (Item 49/25) DCP Amendment - Update Acoustic Requirements for Active Centres for Exhibition

File No: 25/35689

## <u>Summary</u>

As parts of the Burwood LGA transition to higher-density living, it is vital to update local planning controls to ensure that new developments, or substantial alterations and additions, incorporate essential acoustic measures to protect amenity and manage impacts from active and vibrant city environments for the benefit of both current and future residents and visitors.

This report proposes amendments to the acoustic amenity provisions in Parts 3 and 4 of the Burwood Development Control Plan (BDCP). The amendments would apply to Residential Accommodation, Tourist and Visitor Accommodation, Places of Public Worship, Hospitals, Medical Centres, Respite Day Care Centres, and Educational Establishments or Centre-based Child Care Facilities within the Burwood Town Centre, the R1, R3, E1 and MU1 zones, and areas where a Special Entertainment Precinct may apply.

The intent is to strengthen acoustic standards to support housing delivery in mixed-use and entertainment precincts, while ensuring a high level of protection for residents in the Burwood Town Centre, higher-density neighbourhoods and other active areas.

# (Item 50/25) DCP Amendment - Update to Tree Permit Provisions - Endorsement for Public Exhibition

## <u>Summary</u>

State Environmental Planning Policy (Biodiversity and Conservation) 2021 (the SEPP) establishes the framework for regulating the clearing of trees and vegetation in non-rural areas, which includes the Burwood LGA. The Burwood Development Control Plan (BDCP) operates in conjunction with the SEPP and provides a local framework for managing tree-related approvals.

This report proposes an amendment to Clause 6.1 – Preservation of Trees and Vegetation of the BDCP. The intent of the amendment is to revise and clarify the provisions of this Clause to ensure alignment with Chapter 2 of the SEPP and with Council's Sustainable Burwood Plan.

The amendments also seek to provide greater clarity and consistency with customer expectations in relation to tree removal and pruning within the Burwood LGA, with the aim of improving the overall customer experience.

Provisions are being updated to reference current legislative requirements, incorporate additional merit assessment considerations (including the appropriateness of trees located within three metres of residential dwellings in line with complying development provisions), strengthen character assessment criteria, and introduce replacement ratios of two or three trees for every one removed, based on the extent of canopy cover loss.

# **Summary**

Burwood is a major public transport hub, with a high number of bus routes operating along Burwood Road and surrounding streets, serving a growing population of residents, commuters, and visitors. Encouraging greater use of public transport will help ease traffic congestion along Burwood Road and improve access to the Burwood Town Centre.

Digital and smart bus stop signage has been successfully trialled in other parts of Sydney, including the City of Sydney and Macquarie Park during the Epping to Chatswood Rail Link upgrade. These signs provide real-time information on bus arrivals, capacity, service changes, and disruptions. The introduction of smart bus stop technology in Burwood would improve the commuter experience and support Council's broader goals of adopting smart city initiatives.

Digital bus signs can be solar powered and remotely updated, allowing flexibility as bus routes and services change. Positive feedback from previous trials demonstrates the potential benefits for both public transport users and the wider community.

This proposal aligns with Council's digital strategy and aims to improve connectivity, accessibility, and sustainability in the Burwood Town Centre.
